- (3) Children of those belonging to the All India Services/Central Services liable to inter-state transfer, migrants from out of State who are temporarily put up in this State/employees of all India level business/commercial and industrial establishments and Anglo-Indians shall get preference in admissions.

- (4) Admission to pre- primary stage, should be done in the month of April every year.
- (5) The NO OBJECTION CERTIFICATE along with the conditions subject to which the same has been issued should be exhibited in a conspicuous place in the Chambers of the Principal/Head Master/Head Mistress, for the benefit of general public.
- (6) For starting the pre-primary school (Nursery/LKG/UKG etc.,) the management shall obtain prior permission by registering the same in accordance with the Karnataka Educational Institutions(Classification and Registration) Rules, 1997.
- (7) Any other conditions that may be imposed in future.
